During COVID-19, we partnered with the local public radio, local state government & other community radio stations to debunk misinformation related to COVID-19 for larger impact & amplification. This was done free of charge in the public interest and did not involve any financial consideration. We also organize capacity-building workshops in debunking misinformation for a variety of stakeholders including students, civil society, media & state agencies, etc. These are also done free of charge.

The other verticals in the organization work with academia & specific state agencies on evangelizing open data (to encourage the state to publish more data in the public domain), and also sell subscription services to our Data & AI products. The partnership with state agencies or other entities for this work has no relation or impact on our fact-checking work and both are independent of each other. We do around 100 fact-checks every month as listed in the links above on a wide variety of topics.

We have a detailed methodology that is meticulously followed for every fact check. The sources used for fact-checking are government sources and other credible primary sources. Each of the sources/evidence is hyperlinked in the fact check. The rating methodology is also standardized as explained in detail in the methodology. The methodology page explains our process in detail and lays out the procedure we follow.

To fact-check claims and represent data in easily understandable formats, we use charts, tables, illustrations, etc. The methodology & sources are consistent across all our articles on diverse claims.
