Fact-checked claims are primarily viral content in areas like Politics, Health, Science, Climate, and Government Schemes. Telugupost monitors social media, examines memes/images, and reviews news, speeches, and press releases.

Verification involves systematic use of authentic sources and tools. Methods include reverse image searches (Google, Yandex), video analysis tools (Invid), consulting local authorities and police for official data, and referencing authentic news articles. Contacting individuals related to claims and consulting experts are also employed when necessary. Multiple tools and methods are used per claim.

Fact checks are published as articles detailing the claim, verification process, and sources in simple language. Authoritative sources (news websites, image sites, official documents) are cited. Data may be presented in tables/charts. Conclusions are withheld if information is inadequate. All fact checks are sub-edited.
